Who we are.

Leasetech Limited (Leasetech, We, Us, Our) is a Commercial Finance Broker. Our registered office address is 20-22 Wenlock Road, London N1 7GU. Leasetech is Authorised and Regulated by the Financial Conduct Authority, FRN 810303.

How we will use the information about you.

We take your privacy seriously and will use your personal information in several ways which will help Us and Our funders make lending decisions, assist with fraud prevention and audit, and for statistical analysis and credit reference checks. We may share your information with, and obtain information about you from you and credit reference agencies or fraud prevention agencies and Our funders. Details of these funders and how they may process your data can be found on Our website www.weareleasetech.com/policies. We may also be required to process the personal data of any person linked to your finance application, including, inter alia, joint applicants, shareholders (with at least a 25% share in your business), directors, and partners. Information you provide may be put onto a register of claims and shared with other insurers to prevent fraudulent claims. We will not disclose your information to any company outside of Our funder panel except to help prevent fraud or if required by law to do so. We will inform you about which funders we are using and their privacy notice can be found on Our website www.weareleasetech.com/policies.

Your personal data.

What we need:

We collect personal data about you which may include name, address, email, dependents, financial status, date of birth, photo ID's, telephone / mobile numbers and other special types of information or location-based information.

Why we need it:

We need to know your personal data to provide you with an accurate recommendation for your personal circumstances. We will not collect any personal data from you that We do not need to provide and oversee this service to you. For processing of data to be lawful under GDPR, Leasetech use your consent to process your data for the performance of a contract.

What we do with it:

All the personal data We use is controlled by Leasetech in the UK, however, for the purposes of IT hosting and maintenance, this information is located on servers within the European Union. No 3rd parties have access to your personal data unless the law allows them to do so. We have a Data Protection regime in place to oversee the effective and secure processing of your personal data. We may pass your data to Leasetech partners to provide you with offers of products suitable to meet your requirements. Your data is stored electronically on cloud encrypted server based in the UK.

How long we keep it:

We are required to keep your basic personal data, such as name, address, contact details and proposal application for a minimum of 6 years, after which time it will be destroyed. The information used for marketing will be kept by us until you notify us that you no longer wish to receive marketing information.

What are your rights?

If at any point you believe retained information is incorrect you can request to see this information and even have it corrected and deleted. Providing you with this information is free of charge, but charges may apply for excessive requests. If you wish to raise a complaint on how We have handled your personal data, you can contact our Board of Directors (hello@weareleasetech.com), who will investigate the matter. You have the right to withdraw consent and object at any time which means that We cannot process your data. If you are not satisfied with Our response or believe We are not processing your personal data, in accordance with the law, you can complain to the Information Commissioner's Office (ICO).

Automated decision making.

Leasetech will pass your data to Our funder panel who may use automated decision-making in respect of your application for finance. We will only collect the minimum amount of data needed and have a clear retention policy for the profiles We create.

You have the right not to be subject to a decision based solely on automated processing. We should be made aware of any objection prior to submission of any finance application. You can request human intervention and challenge a decision made this way by contacting hello@weareleasetech.com.
